## 1. Introduction

Load box Freight Solutions CC t/a A-team Express (hereinafter referred as “A-Team Express”) respects the right to privacy and confidentiality of our potential and existing clients’ personal information.

The Protection of Personal Information Act describes personal information as information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person. This includes data such as names, contact details and identity numbers.

This Policy explains how we obtain, use, and disclose our clients’ personal information, in accordance with the requirements of the Protection of Personal Information Act (“POPIA”) and the Electronic Communications and Transaction Act (“ECTA”).

At A-Team Express we are committed to protecting our clients’ privacy and to ensure that their personal information is collected and used properly, lawfully, and transparently.

A-Team Express reserves the right to amend this Privacy Policy or add provisions to it at any time by publishing an updated version on our website.

## 2. Objective

The objective of this Policy is to ensure compliance with the Protection of Personal Information Act and the Electronic Communications and Transaction Act by:

- 2.1. Setting out our strategy to uphold the rights to privacy and confidentiality of our clients’ personal information.
- 2.2. Notifying data subjects how we will handle personal information that we obtain.

## 3. Information we collect

- 3.1. A-Team Express collects personal information in various instances, including when:
  - 3.1.1. data subjects contact A-Team Express or request information or services;
  - 3.1.2. A-Team Express services to data subjects;
  - 3.1.3. persons apply for employment at A-Team Express;



- 3.1.4. when persons use A-Team Express' websites or engage with A-Team Express through social media.
  - 3.1.5. A-Team Express may collect the information directly from a data subject or from third parties (such as regulators, government authorities and registries).
  - 3.1.6. Cross-boarder transaction have been concluded and shipments/freight are received in the Republic of South Africa or shipped out of the Republic; and
  - 3.1.7. When foreign currency enters the Republic.
- 3.2. The interaction with A-Team Express on A-Team Express' website will result in the collection of information regarding the person's activities on the website. Similarly, when anyone engages with the company via any one of A-Team Express' social media platforms. This information includes, but is not limited to, the person's name, contact details and information regarding the matter with which they need assistance.
- 3.3. In the course of engaging with clients, A-Team Express will naturally be exposed to and collect personal information which includes the data subject's name, contact details, financial information as well as other necessary information.
- 3.4. As part of its recruitment processes, A-Team Express collects information from graduates and employment applicants. This information includes educational information as well as employment history. By inquiring regarding employment opportunities at A-Team Express or applying for employment, applicants are deemed to provide their consent to A-Team Express' processing of their personal information for recruitment purposes, which may include screening as well as background and reference checks.

#### **4. Processing of Personal Information**

- 4.1. A-Team Express may process personal information:
  - 4.1.1. to provide services to clients;
  - 4.1.2. to comply with legal or regulatory obligations;
  - 4.1.3. if a data subject has provided their consent; or
  - 4.1.4. if the processing is allowed by law.



- 4.2. The purposes for which A-Team Express processes personal information include, but are not limited to:
- 4.2.1. marketing and promotion of A-Team Express services;
  - 4.2.2. providing and improving services to clients;
  - 4.2.3. improving users' experience when using A-Team Express' websites;
  - 4.2.4. enabling A-Team Express' internal operations;

## **5. Information Security**

5.1. We are legally obliged to provide adequate protection for the personal information we hold and to stop unauthorised access and use of personal information. We will, on an on-going basis, continue to review our security controls and related processes to ensure that our client's personal information remains secure.

5.2. Our security policies and procedures cover:

- 5.2.1. Physical security;
- 5.2.2. Computer and network security;
- 5.2.3. Access to personal information;
- 5.2.4. Secure communications;
- 5.2.5. Retention and disposal of information;
- 5.2.6. Acceptable usage of personal information;
- 5.2.7. Governance and regulatory issues;
- 5.2.8. Monitoring access and usage of private information; and
- 5.2.9. Investigating and reacting to security incidents.

## **6. Disclosure of Information**

6.1. We may disclose your information:

- 6.1.1. Where we have a duty or a right to disclose in terms of law, industry codes or a Court Order;
- 6.1.2. Where we believe it is necessary to protect our rights;



6.2. The third parties to whom we disclose personal information include, but are not limited to:

6.2.1. third party service providers to A-Team Express or its clients;

6.2.2. government authorities and registries, organs of state, regulators, courts, tribunals and law enforcement agencies.

## **7. Transfer of Personal Information**

Personal information collected by A-Team Express may be transferred to persons in other countries. Those countries' laws might not protect personal information in the same way or on the same level as the law in the data subject's country. However, A-Team Express will take reasonable steps to ensure that recipients in other countries have appropriate privacy measures in place.

## **8. Retention of Personal Information**

A-Team Express retains personal information for as long as may be reasonably necessary in accordance with applicable law.

## **9. Cookies**

A-Team Express' websites makes use of cookies.

A website visitor may disable or decline cookies. However, if the visitor does so, their user experience on the site may be diminished.

## **10. Direct Marketing**

A-Team Express may send marketing and promotional communications and material to persons. Recipients may opt-out from receiving such communications by contacting A-Team Express at the details provided below.

### 11.1 Access to Information:

You have the right to request a copy of the personal information we hold about you. ### 11.2 Correction of your Information:

### 11.3 Right to Object

In terms of section 11(3) of the Protection of Personal Information Act you have the right to object to our processing of your personal information.

### 11.4 Right to Complain

You have the right to lodge a complaint with the Information Regulator should you feel that your personal data was not handled in a responsible manner.
